#### 10<sup>TH</sup> CHINA-SOUTH ASIA EXPOSITION & THE 30<sup>TH</sup> CHINA KUNMING IMPORT AND EXPORT FAIR 2026 (SOUTH ASIA PAVILLION) From 11<sup>th</sup> – 16<sup>th</sup> June 2026, Kunming, China

The Department of Commerce of Sri Lanka, in collaboration with the Sri Lanka Embassy in China, is organizing Sri Lanka participation at the China-South Asia (CSA) Expo (Kunming Fair), which is scheduled to be held from **11<sup>th</sup>-16<sup>th</sup> June 2026, at Dianchi International Convention and Exhibition Centre, Kunming, China.**

The China-South Asia (CSA) Expo and China Kunming Import and Export Commodities Fair is jointly sponsored by the Ministry of Commerce of the People's Republic of China and the People's Government of Yunnan Province in collaboration with the Commercial authorities of South Asian countries.

#### ➤ OBJECTIVES

The objective of organizing the Sri Lanka pavilion in this fair is to give an opportunity to Sri Lankan exporters to showcase and promote Sri Lankan products in this prestigious event, aiming overall promotion of the country's trade, tourism and investment potential.

#### ➤ FOR WHOM

Applicants are invited from the sectors of Ceylon Tea, Gems & Jewelry, Coconut Kernel and Fiber (Cocopeat/Fiber, Milk, Oil), Food & Beverage, Processed Food products, Fresh Fruit (Pineapple), Apparel & Clothing, Organic Wellness products including Ayurveda products, Porcelainware, Furniture items, Spices & Essential oils (Pepper, Cinnamon, Nutmeg, Cloves only) Handicrafts including Batiks, Paintings, Artwork, Electronics Appliance and Innovative machinery, Tourism etc.

#### ➤ COST OF PARTICIPATION

A standard constructed booth (3\*3=9.0 sqm) will be provided **free of charge** for each participating company. The logistics cost of the participants, including the airfare, visa fees, accommodation, domestic transport, and other relevant costs etc., has to be borne by the selected companies. The Department may assist in obtaining visas for the participants as appropriate.

#### ➤ APPLICATION AND SELECTION

The duly filled application should be submitted through the link on or before **25 February 2026**.

Shortlisted applicants will be interviewed by a panel of experts appointed by the Department of Commerce.
